Pentecost Order Form and Performance Agreement

This Order Form and Performance Agreement (hereafter, the Agreement) allows the signatory's organization to perform *Pentecost: The Musical* (hereafter, *Pentecost*). By signing this Agreement, the individual represents and agrees to the following:

1. That the organization, _____ (hereafter, Organization), located at _____ seeks to perform *Pentecost* on the following approximate dates and number of performances: _____ (dates); _____ (total number of performances currently planned).
2. It is agreed that *Pentecost* can be performed through the purchase of a Pentecost Pack at the cost of \$185 (inclusive of all taxes and domestic shipping, make all checks payable to Restoring Truth Ministries, LLC). The required payment is provided with this signed Agreement. The Pentecost Pack will be sent to the Organization's address above within approximately 2 weeks from the receipt of this Agreement and will contain:
 - 24 copies of the complete script, including song lyrics.
 - 2 copies of the musical score for 25 songs in *Pentecost*
 - 3 CDs of the instrumental recording of all songs
 - 2 Set drawings and drawings of the dance sequences

(If applicable) In addition to the Pentecost Pack, the Organization wishes to purchase additional copies of the indicated *Pentecost* materials and has added this cost to the \$185 cost for the basic Pentecost Pack (note, if *Pentecost* will not be performed but copies of the script or CD are being purchased for classroom/small group use, mark the quantities desired below and enter the total without the \$185 for the Pentecost Pack:

- _____ additional copies of the musical score for \$7 each for a total of \$ _____ (can only be ordered with the purchase of a Pentecost Pack)
- _____ additional CDs at a cost of \$7 (\$8.50 without the purchase of a Pentecost Pack) each for a total of \$_____

The resulting total amount of the enclosed check is for \$_____.

3. The script and music of *Pentecost* are copyrighted; no copies of the script, CD, or any Pentecost Pack item will be made and if additional copies of any item are required, they will be ordered from Restoring Truth Ministries, LLC.
4. It is agreed that the Pentecost Pack contents will not be sold or given to a third party under any circumstances; no video or audio recordings of the musical or *Pentecost* songs will be made and sold.
5. The terms and conditions of this Agreement are valid for the performances and dates listed above. Should *Pentecost* be subsequently performed by the Organization, a new Agreement will be submitted at least two months prior to the performance and the costs, royalties, terms and conditions then in effect would apply. If the Organization has sufficient supplies (scripts, CDs, etc.) from an earlier purchase of a Pentecost Pack and related materials, then a Pentecost Pack need not be reordered when a new Agreement is submitted.
6. In addition to payment for the Pentecost Pack and any additional copies, it is agreed that a royalty payment will be collected for all attendees of *Pentecost* and sent to Restoring Truth Ministries, LCC within 3 weeks of the performance of *Pentecost*. If all performances of *Pentecost* occur within a week, for example if *Pentecost* is the spring musical, the payment for all performances is due within 3 weeks of the final performance. If the performance of *Pentecost* extends beyond a week, payment is due within 3 weeks of the end of each weekly performance or series of performances occurring during a week.
7. The royalty payment due will be equal to fifty cents (\$0.50) for each member attending the musical that is not part of the performing cast, direction, band, stage and back stage crew, or otherwise directly involved in the performance of *Pentecost*. For performances that sell tickets to audience members, a royalty payment would be made for each ticket sold but would also apply to those who attend as non-paying guests. If the musical is performed without an admission cost, royalty would be due for all audience members in attendance. It is the responsibility of the Organization to ensure that all royalty fees due are collected and submitted on time.
8. Each royalty payment and the payment for the Pentecost Pack and materials will be sent to Restoring Truth Ministries, LLC (address provided when an Order Request Form is submitted). Royalty payments will include the following:
 - A. Dates of performance covered by the royalty payment.
 - B. Cumulative number of audience members in attendance for all performances covered.
 - C. Total payment, calculated as 50 cents (\$0.50) times the cumulative number of audience members.
9. It is agreed that any program printed for the performance of *Pentecost* will contain the following:

About the playwright. John Wynne is the playwright of *Pentecost*. He is also the director of Restoring Truth Ministries, LLC and co-author of *Repairing the Breach* (2008), a major work that chronicles the war of worldviews touched upon in *Pentecost*. He wrote *Pentecost* in 2009 to help introduce audiences to the war of worldview concept and to present important lessons in Christian apologetics in an entertaining and memorable manner. By signing this Agreement, the signatory, and the Organization which the signatory must be authorized to represent for purposes of this Agreement, agree to the provisions herein; commit to taking prudent measures such that all copyrights are observed and that all timely payments are made; and understand that a material violation of the provisions in this Agreement could result in legal action.
